- Invitation for Bids (IFB) No. 20181 requested competitive sealed bids for firearms and related accessories on behalf of Placer County Sheriff's Office.
- Over 150 firms, including minority businesses and women's business enterprises, were notified of this bid opportunity.
- Bid was active for 16 calendar days and closed on 5/06/2021.
- Thirteen firms viewed the bid online in bids&tenders; three bids were submitted prior to the bid closing date and time.
- LC Action Police Supply submitted the shortest delivery time for Category A and is the lowest responsive and responsible bid for Category C; ProForce Law Enforcement submitted the lowest responsive and responsible bid for Category B.
